### Storyline and Comments

**Storyline:** There are two parralel story lines which continue from episode 58. Thefirst centres on Dean Bulmer who is up on trial for murdering his partner during a bank robbery, as well as seriously wounding one of the female tellers. As the trial progresses, another body is discovered and forensic identifies it as the partner that was supposedly killed during the robbery. We follow the detectives as they try to identify the original body and prove that he too was killed by Bulmer, the man on trial. At the end of part 1, Bulmer is released due to lack of evidence and upon his release goes on to murder a convenience store clerk. The Squad continues to gather evidence to prove him guilty. In the second story line we follow what may be the end of Cold Squad as a seperate entity. Rumours abound as to the possibility of merger with the homicide department. When forensics admits to the error in identifying the original body in the Bulmer trial, Cold Squad's fate seems sealed, as well as that of Nicco, who after the release of Bulmer, decides to apply for a transfer to Homicide.

**Comments:** Once again we are looking for new and interesting actors for season four. DO NOT SUGGEST PEOPLE WHO HAVE ALREADY DONE "COLD SQUAD" in season 2 or 3.
